## Campaign CIM Finance - UEFA Champions League 2024

### Conditions of participation:

1. CIM Financial Services Ltd (hereinafter "Cim Finance"), presents the "UEFA Champions League 2024" promotional campaign, in partnership with Mastercard, (hereinafter the "Offer").
2. The Offer is valid from March 18 to April 7, 2024 (dates included).
3. One winner will be chosen and announced within 15 days following the campaign, to witness one of the semi-final matches, live.
4. The winner will win a package for 2 people to attend the 2024 UEFA Champions League semifinal match, in the organizing country (hereinafter referred to as the "Prize"). The Prize includes two air tickets, two match tickets, accommodation, transportation to and from the match, and a prepaid Mastercard in the amount of USD 250.
5. The Offer is valid only for adult individuals of Mauritian nationality and residing in Mauritius.
6. The Offer is open to all CIM Finance Mastercard credit individual cardholders, excluding Business cards.
7. Each customer, will have to make payments, in Mauritius and/or abroad, only with a valid CIM Finance Mastercard credit cards, during the promotional period.
8. The recording of transactions carried out in Mauritius and abroad will be done according to the date of authorization of each transaction, that is to say, the day on which the transaction took place. The winner will be the card holding the highest no. of purchases excluding account verification transactions. In case of ex aequo, the highest spending cumulative amount during the promotional campaign period will be considered for the ex aequo cards. These will be followed by the highest outstanding balance on the card accounts as a third criteria, in case the first two criteria do not distinguish a specific card.
9. The card must be in good standing or not blocked, and managed in an appropriate and satisfactory manner, at the discretion of the CIM Finance. In the event that the account is voluntarily or involuntarily closed, terminated or blocked, for any reason, before or after the promotion, CIM Finance reserves the right not to award the Prize.



10. CIM Finance employees and close relatives, persons under the age of 18, politically exposed persons, holders of Business and

Corporate credit cards are not eligible for the Offer. This ineligibility criterion applies to primary and secondary cards, cards linked to a joint account, and cards linked to CIM Finance employee accounts.

11. Transactions carried out at automated teller machines (“ATMs”), at bank branch counters (any bank), at financial institutions, in casinos as well as bets and payments or transactions in cryptocurrency will not be counted.

12. The winner, as well as the person accompanying, must each have a valid passport, a valid visa and any other necessary document at his/her own expense.

13. CIM Finance cannot be held responsible in the event that the winner cannot claim the Prize for a specific reason, or in the case of a dispute relating to the application of these conditions. The Prize is non-transferrable and cannot be converted to cash.
